Privacy policy

What is this privacy policy for?

Oliver Haggard Ltd (Registered office: 198 London Road, Portsmouth, England, PO2 9JE Registration Number: 10062660) is committed to protecting your personal information, being transparent about what data we hold and giving you control over how we use it.

The purpose of this privacy policy is to give you a clear explanation about how Oliver Haggard Ltd uses personal and behavioural information we collect from you.

We are clear on what data we hold and what we do with it.

In collecting and using your personal information, we will be clear about what we are doing and make sure that you understand the way in which we are using it. Also, we won't sell your information to anyone.

You control the data we hold on you.

If requested, we will delete your personal information securely and swiftly.

We have in place appropriate security measures to protect your information from unauthorised access and will only work with third parties necessary to the completion of any services you requested from us.

How will we use this information?

Other than is required by law or as set out in this Privacy Policy, Oliver Haggard Ltd will not disclose, rent or sell the Personal Information to any third party. We may disclose your personal information to the purchaser (or prospective purchaser) of any business or asset that we are (or are contemplating) selling. Employees, contractors and agents of Oliver Haggard Ltd may be given access to any personal information which we collect but their use shall be limited to performance of their duties in relation to the services provided by Oliver Haggard Ltd. We contractually require these service providers to safeguard the privacy and security of personal information they process on our behalf in line with GDPR and authorise them to use, disclose and store the information only as necessary to perform services on our behalf or comply with legal requirements.

Oliver Haggard Ltd will take reasonable precautions to prevent the loss, misuse or alteration of your Personal Information.

Those who have access to your personal information are required to keep that information confidential and are not permitted to use it for any purpose other than that to the services and products offered by Oliver Haggard Ltd. Once we have received your information, we will use strict procedures and security features to protect data and prevent unauthorised access.

How long does Oliver Haggard Ltd keep my personal information?
